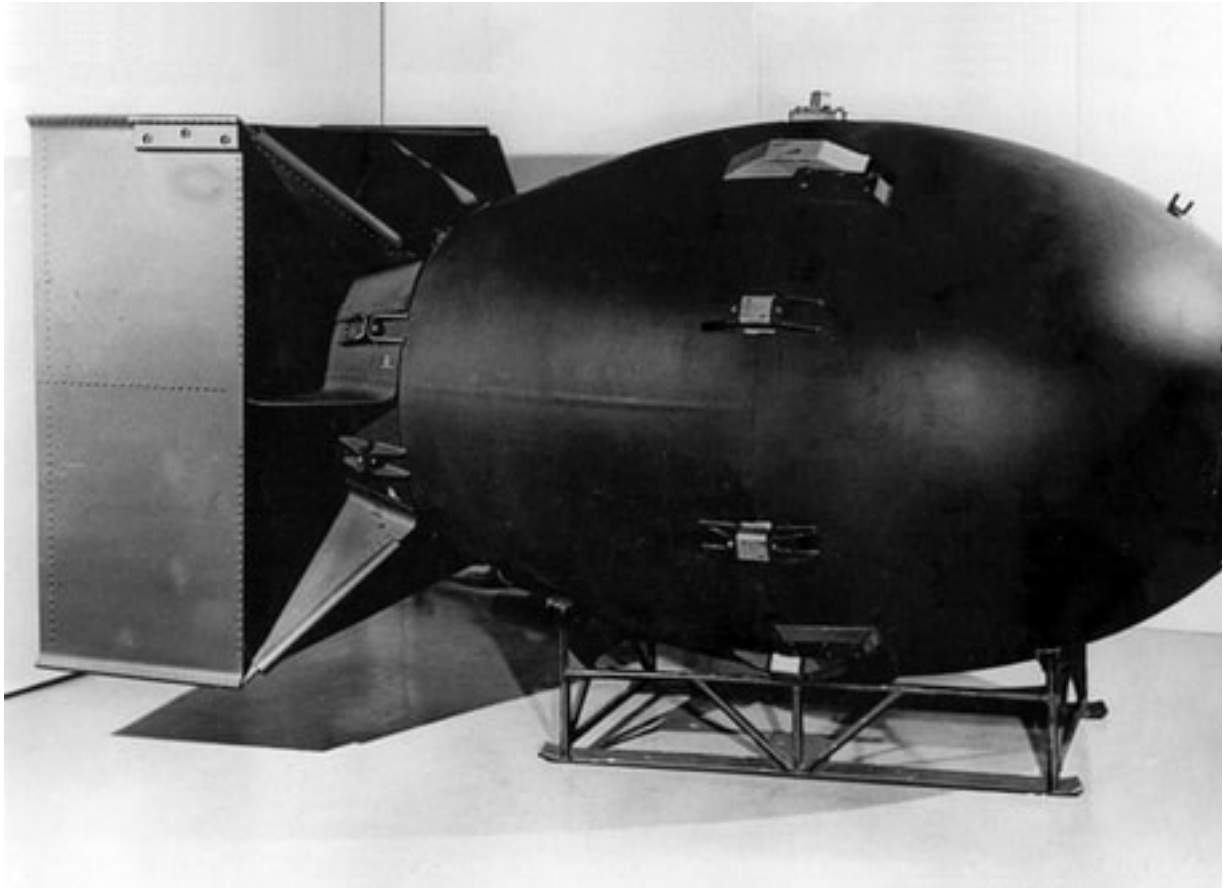

"In Hiroshima I was prepared for radically different sights. But, to my surprise, Hiroshima looked exactly like all the other burned-out cities in Japan. There was a familiar pink blot, about two miles in diameter. It was dotted with charred trees and telephone poles.

Only one of the cities twenty bridges was down. Hiroshima's clusters of modern buildings in the downtown section stood upright. It was obvious that the blast could not have been so powerful as we had been led to believe.

It was extensive blast rather than intensive. I had heard of buildings instantly consumed by unprecedented heat. Yet here I saw the buildings structurally intact, and what is more, topped by undamaged flag poles, lightning rods, painted railings, air raid precaution signs and other comparatively fragile objects.

At the T-bridge, the aiming point for the atomic bomb, I looked for the "bald spot" where everything presumably had been vaporized in the twinkling of an eye. It wasn't there or anywhere else. I could find no traces of unusual phenomena.

What I did see was in substance a replica of Yokohama or Osaka, or the Tokyo suburbs - the familiar residue of an area of wood and brick houses razed by uncontrollable fire. Everywhere I saw the trunks of charred and leafless trees, burned and unburned chunks of wood.

The fire had been intense enough to bend and twist steel girders and to melt glass until it ran like lava - just as in other Japanese cities. The concrete buildings nearest to the center of explosion, some only a few blocks from the heart of the atom blast, showed no structural damage.

Even cornices, canopies and delicate exterior decorations were intact. Window glass was shattered, of course, but single-panel frames held firm; only window frames of two or more panels were bent and buckled. The blast impact therefore could not have been unusual." -Major Alexander Seversky.

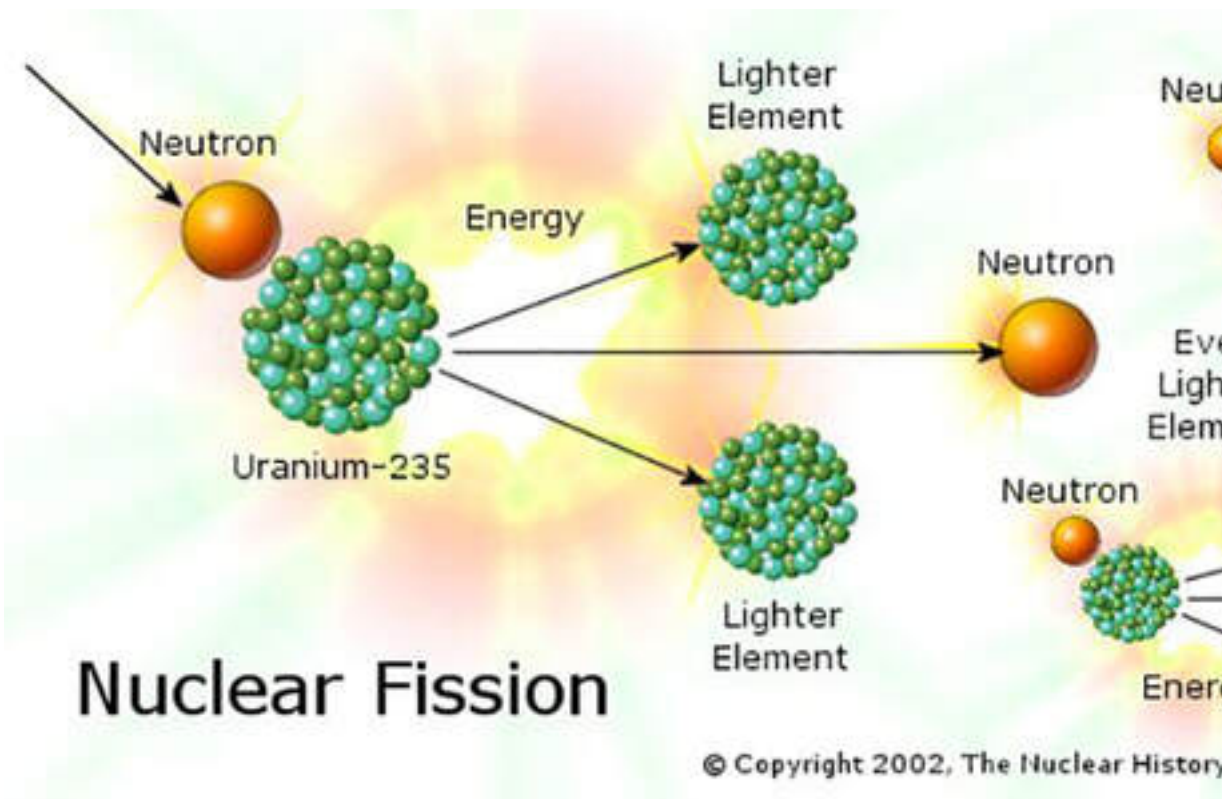

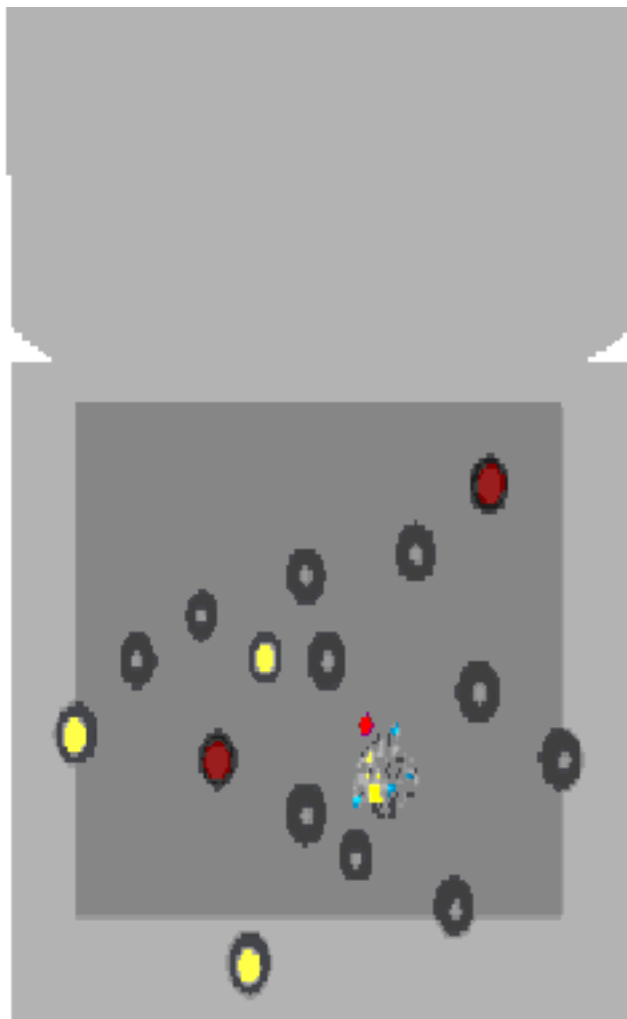






# Nuclear Fission or Split

Radioactive decay. Nuclear fission can occur without *neutron* bombardment as a type of *radioactive decay*. This type of fission (called *spontaneous fission*) is rare except in a few heavy isotopes. Nuclear reaction. [https://en.wikipedia.org/wiki/Nuclear\\_fission](https://en.wikipedia.org/wiki/Nuclear_fission)



A visual representation of an induced nuclear fission event where a slow-moving neutron is absorbed by the nucleus of a

*uranium-235 atom, which fissions into two fast-moving lighter elements (fission products) and additional neutrons.*

*Most of the energy released is in the form of the kinetic velocities of the fission products and the neutrons.*



## **Nuclear *fission***

**was discovered 1938 in Germany**



*It occurs, when an atom **A** (e.g. **Uranium 235**) absorbs a free neutron **n** under controlled conditions.*

*A splits into two smaller atoms **B** and **C** that fly apart and releases two free neutrons **n**,*

*energy / heat **E** and radiation **R** as per formula:*



*The **strong forces** keeping the protons and neutrons of atom **A** together disappear producing **E** and **R**, while the two new, free neutrons **n** have problems finding other atoms **A** to continue fission. If a free neutron **n** is not absorbed by another atom **A**, it dies after ten minutes or becomes a proton and an electron and a meson.*

*The free neutrons **n** may produce more fission, but only due to moderation (slowing down!) inside a peaceful nuclear power plant/reactor (or a laboratory).*

*This **fission** has been studied in laboratories for years and is*

described in peer reviewed papers.

It takes place in nano-scale - the atoms **A** are very, very small and the neutrons **n** are even smaller and are very very fast and fission can be done by moderation in nuclear power plants.

A **fission bomb** on the other hand, otherwise known as a nuclear bomb or a-bomb, is a **fission** reactor designed to liberate as much energy **E** as rapidly as possible to kill people (!) in a nano-second, before the released energy causes the reactor and content to melt and the chain reaction to stop, we are told.

This **explosive, military fission bomb** was secretly invented 1945 by criminal pseudo-scientists / terrorists in the USA, evidently without any peer review idedor similar.

It kills people, we are told, because the two (or three), free neutrons **n** immediately, in no time, are absorbed by two or three other atoms **A** as per (1) producing four or six more atom splits, + more free neutrons **n**, etc, etc, producing billions of atom splits and new atoms **B** and **C** flying around during a nano-second releasing plenty energy/heat **E** and radiation **R** = an atomic bomb **explosion, FLASH**, radiation, shock wave, mushroom cloud killing civilians.

This - **killing people - military, nuclear physics** is totally phoney, which I explain further down. There is no evidence that it works and exists. **It cannot be and has never been tested in a laboratory of course.**

A mass of atoms **A** that fission melt at once - no explosion. There are no peer reviewed scientific papers about it anywhere. But to become a nuclear expert PhD, you must agree that **explosive, military fission** is a fact!

*It is simple!*

***Nuclear weapons cannot explode and Japan and USA keep it secret by law since 1945!***

*No military commander or political dictator can push a button, drop a nuclear bomb or launch a nuclear missile to wipe out an enemy.*

*Fantasy, secret nuclear, military weapons of mass destruction need **two** small, **non-critical** masses of fissile material like **Uranium-235** as fuel to ignite (!), when suddenly brought together to **one critical** mass according to secret nuclear, military experts.*

The **critical mass** then explodes and produces a **FLASH** that lasts nano-seconds and vaporizes and **radiates** a **mass** of children looking on and a town below a dirty mushroom cloud.

It creates **FEAR!** It is very easy to fool people with fake information to create **FEAR!** But you must avoid **spontaneous fission**:

*"Until **detonation** (ignition, explosion) is desired, a nuclear weapon must be kept **subcritical**. In the case of a uranium bomb used to destroy Hiroshima, this is achieved by keeping the fuel in a number of separate pieces, each below the critical size (mass), either because they are too small or unfavorably shaped.*

*To produce **detonation** (ignition, explosion), the pieces of pure Uranium-235 were brought together (!) rapidly. This was achieved by firing a piece of **Uranium-235** down a gun barrel onto another piece. This design is referred to as a **gun-type fission** weapon.*

*A theoretical 100% pure **Plutonium-239** weapon could also be constructed as a **gun-type** weapon ... In reality, this is impractical because even "weapons grade" **Plutonium-239** is contaminated with a small amount of **Plutonium-240**, which has a strong propensity toward spontaneous fission.*

*Because of this, a reasonably sized **gun-type** weapon would suffer nuclear reaction (the bomb would melt) before the masses of plutonium would be in a position for a full-fledged explosion to occur.*

*Instead, the **Plutonium-239** is present as a subcritical sphere (!), which may or may not be hollow. Detonation (ignition, explosion) is produced by exploding a shaped charge surrounding the sphere, increasing the **density** (!) to produce a prompt critical configuration (!). This is known as an **implosion type fission** weapon. It was used to destroy Nagasaki."*

Imagine what nonsense

the secret nuclear, military experts invented **1945!** Increasing **density!**

Of course there has been some developments of fake nuclear weapons since 1945. One example is **Fourth Generation Nuclear Weapons: Military effectiveness and collateral effects** (2008):

The paper begins with a general introduction and update to **Fourth Generation Nuclear Weapons** (FGNW), and then addresses some particularly important military aspects on which there has been only limited public discussion so far.

These aspects concern the unique military characteristics of FGNWs which make them radically different from both nuclear weapons based on previous generation nuclear explosives and from conventional weapons based on chemical-explosives, bla, bla, bla.

You wonder what idiots spend time with this nonsense. People maybe believe it today! But real **fission** does not work like that!

In a peaceful nuclear power plant **fission** takes place all the time; no **FLASH**, no smoke, no *critical* masses, no increases of densities. Steam/electricity is produced as required by *moderating* the **fission** in a **reactor vessel** using **control rods**! The **uranium fuel** is 100's of tons of **uranium oxide** molecules inside a **reactor vessel** protected by a **containment building** that slowly is transformed by **fission** into smaller molecules.

There are no *secrets*! No *plutonium* is produced when electricity is produced! It is however only 0.7% of the **uranium oxide** molecules that **fission**, i.e. those with **235** protons and neutrons in the uranium atoms. They become other atoms and waste.

The 99.3% of the uranium oxide molecules with **238** protons and neutrons in the atoms do not **fission** and become more waste. **Nuclear waste** is neither particularly hazardous nor hard to manage relative to other toxic industrial waste.

Safe methods for the final disposal of high-level *radioactive* waste inside the **reactor vessel** are technically proven; the international consensus is that geological disposal is the best option.

A key, nearly unique, characteristic of nuclear energy is that **used fuel may be reprocessed** to recover fissile and fertile materials in order to provide fresh fuel for existing and future nuclear power plants. Plutonium may be one result ... so best is not to do it. There is plenty nuclear fuel, **uranium oxide**, available at small cost. The atomic bomb fuel - uranium 235 metal - is completely different.

If an old **reactor vessel** and **containment building** are considered worn out or unsafe after say 60 years, the best solution is to build new ones at the side and not use the old



ones.

The old **containment buildings** can be used as museums or offices. Everything else at a nuclear power plant can be re-used forever. Let's face it nuclear power is the best, safest and most economical way to produce electricity.

Only twerps believe in *critical masses*, **gun type fission**, **implosion type fission**, **FLASHES**, *radiation*, mushroom clouds, **FEAR**, North Korean a-bombs and false, *secret* nuclear weapons.

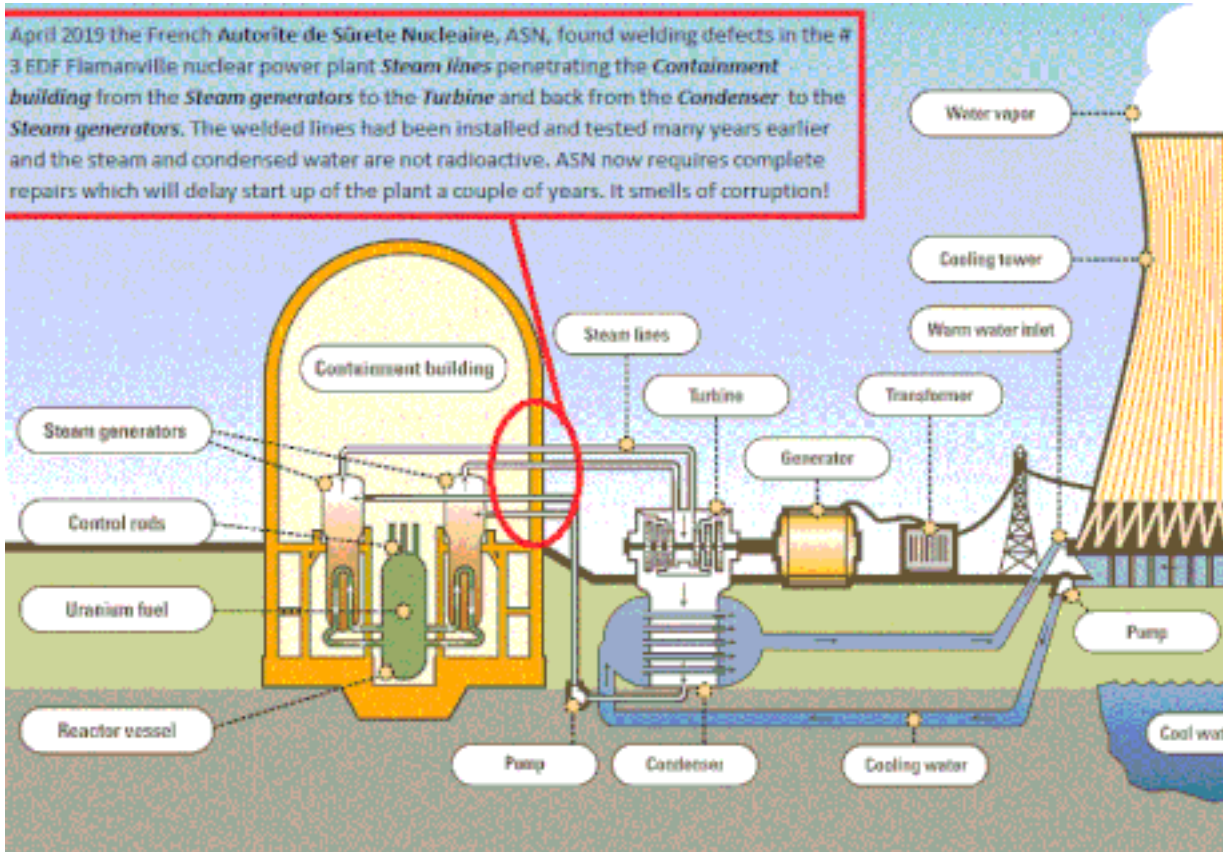

I live in Europe (Southern France) and today, **2014**, it seems USA, 51 years later, protect me with plenty atomic strategic and tactical **B61 Silver Bullet** atomic bombs *created* 1963 with *fixed* tail fins just rivetted to the bomb shell (see photos below) and according

to [www.nrdc.org/nuclear/euro/euro.pdf](http://www.nrdc.org/nuclear/euro/euro.pdf). It is evidently a joke. The B61 Silver Bullet atomic bomb does not work! And what a stupid name of a bomb. Silver bullet!



The **B61 Silver Bullet** bombs are stored in well-known places all over Europe, where they apparently can go off at any time ... even if they do not work.

A U.S. Air Force safety review determined in 1997 that there was a risk of accidental nuclear explosion during service of **B61 nuclear bombs** in NATO's protective aircraft shelters. (p.52 of above [link](#))

**Nobody in Europe reacted 1997! Imagine US/NATO bombs just exploding in store!**

The **B61 Silver Bullet** gravity bomb was *created* in 1963 and was built by the **Los Alamos National Laboratory**, **Los Alamos**, in New Mexico according US propaganda.

**Los Alamos** is a boring town in the mountains 40 minutes by car from **Santa Fe**, capital of **New Mexico**, famous for being the place where enriched **uranium U235** was and is transported in and out of the local atomic bombs factory close to schools and parks full of children. atomic **B61** bomb

production engineering began there in 1965, with full production beginning in 1968 following a series of creative development problems. Luckily no bombs exploded in **Los Alamos**.

Total production of all versions of the **B61 Silver Bullet** atomic bomb was approximately **3 155**, of which approximately **1 925** remained in service as of 2002. Where the other **1 230** bombs are is a **MILITARY SECRET** due to national security considerations. Maybe they have gone missing or were stolen by locals from **Los Alamos**?

2012 there seems to be only 400 **B61s** left:

„The **B61** is about to undergo a major overhaul that the Pentagon estimates will cost up to \$10 billion, or \$25 million per bomb”.

### **NATIONAL NUCLEAR SECURITY ADMINISTRATION**

The U.S. intends to refurbish the remaining 400 **B61** atomic bombs under its Life Extension Program with the intention that the weapons should remain operational until at least 2025:

There are nearly 200 B61 Silver Bullet atomic Bombs in Europe (file photo) – note the fixed tail fins just attached to the end! It will cost USD *one* billions to make them controllable for improved accuracy when dropping on the enemy in order to better protect Europe!

No bomb works though! Imagine that! *The bomb tail fins direct the bomb, while dropping from a warplane – a top secret system! See also below about the new tail fins.*

**An old B61 Silver Bullet atomic Bomb without tail fins being rolled around by some fat US soldiers (or actors?) at Amarillo, Texas, between other B61 atomic bombs. The bomb weighs 320 kg incl. 61 kg of Uranium 235 (*critical mass*) compared to 4 400 kg incl. 61 kg of metal Uranium 235 (*critical mass*) rings of the Hiroshima bomb 1945.**





A B61 Mod 11 weighs 540 kg for unknown reasons. Any B61, with or without tail fins, doesn't work, though! Imagine that! **Where the parachute retarder is located is unclear but probably below the tail fins aft.** The **B61 Mod 12** is available 2014. Only fools believe it works.

„According to **newly published figures**, the United States will (2013) set aside **more than US\$ 10 billion** for a life extension program for the **B61 Silver Bullet atomic bombs** and another USD one billion for **adding controllable tail fins**.

The plan to give new tail fins to nearly **200 B61 gravity bombs** stored in Belgium, the Netherlands, Germany, Italy and **Turkey** would give them new mission and new capabilities. The bombs could be delivered by stealth F35 fighter-bombers.”

Evidently the extremely expensive **B61 Silver Bullet** tactical atomic bomb does not work at all, as explained below. Nobody can say on whom the high cost tactical atomic bomb shall be dropped by a plane, Hiroshima gravity style. National security! Isn't it stupid? ## *Atomic bomb with Parachute Retarder*

Most versions of the old **B61 Silver Bullet** are equipped with a

parachute retarder (currently a 24-ft (7.3 m) diameter nylon/ Kevlar chute) to slow the weapon in its descent from release altitude. This offers the aircraft a chance to escape the blast, or allows the weapon to survive impact with the ground in laydown mode ... we are told.

I have evidently sent my email to Madelyn via Cynthia but then I get no answers from US DoD via her. Try yourself! Madelyn apparently relies on snail mail.

Someone told me (13 December 2013) to send my questions to: **Ms. Madelyn R. Creedon, Assistant Secretary of atomic War for Global Strategic Affairs 2900 War Pentagon, Rm. 3C852A, Washington, DC 20301-2900, USA**

Of course I have done that ... no reply! Imagine old, haggard Madelyn upgrading atomic bombs! Why can't USA use some good looking lady, e.g. Paris Hilton?

„The new tail kit assembly (seen on photo right) is important because it adds a guidance system to the bomb, basically converting it from a gravity-dependent dumb (sic) bomb into a smart one that can be aimed more precisely at a target”,

the **Albuquerque Journal** reported 18 May 2014. Imagine that for 50 years US had dumb atomic bombs without guidance system.



B61 atomic bomb with new US\$ 25 million tail kit (without parachute retarder) at wind tunnel test. What a stupid joke! Can anybody believe the new tail fins can guide anything?

## *The B61 Bomb will vaporize the Plane dropping it – does Obama know?*

If the **B61** bomb is dropped by gravity from 50 meters altitude by a US war plane on the enemy target, it will hit ground with a *vertical* velocity of **31.34 m/s** after only 3.19 seconds (ignoring friction/turbulence that slows down the bomb a little). There is no engine driving the B61. Only its momentum, when released from the plane, drives the bomb when it drops down by gravity.

If the plane + bomb have a *horizontal* velocity of **100 m/s**, the plane will proceed 319 meters, while the bomb is dropping *vertically* 50 meters while also moving forward at same speed. US\$ 1 billion controllable tail fins (+ US\$ 10 billion general upgrade) may of course divert the B61 bomb accurately sideways (and downwards – not upwards because it will then collide with the plane) a little during the vertical drop but during a maximum 319 meters path.

After that the atomic bomb hits the ground at great velocity, say, **104.78 m/s** at angle **17.4°** ... and maybe bounces upwards. If the atomic bomb then explodes, when hitting ground, the plane + pilot above will evidently be vaporized like the children at Hiroshima, as the atomic bomb fire ball and blast/heat wave extends >300 meters within 0.01 seconds!

It seems **US Department of War** and **Ms. Madelyn R. Creedon** are fucking up, again. Luckily the gravity atomic bomb does not work, though, as described below. And there are no planes that can drop the 2014 model **B61-12 atomic gravity bomb**:

Initially the old NATO F-16A/B and Tornado PA-200 aircraft that currently serve in the nuclear strike mission will not be able to make use of the increased accuracy of the B61-12, according to U.S. Air Force officials.

The reason is that the aircraft computers are not capable of „talking to” the new digital bomb. As a result, the guided tail kit on the B61-12 for **Belgian, Dutch, German,**

**Italian and Turkish** F-16s and Tornados will initially be „locked” as a „dumb” bomb. Once these countries transition to the F-35 aircraft, however, the enhanced targeting capability will become operational also in these countries.

Of course there are plenty US intercontinental ballistic atomic bomb missiles too controlled by **drunk generals** like Michael Carey. It is OK. They do not work either.

The US public evidently does not care about costs – **US\$ 11 billion for life extension** and tail fins improvements for better accuracy of something built in the 1960’s that doesn’t work is of no concern to the US public. US\$ 11 billion keeps a lot of idle US military busy though planning ... what ... terrorism ... controllable tail fins?

It would cost only US\$ 1 000:- to dismantle a **B61 Silver Bullet** and ship it back to USA but it seems US national security will suffer. But, blah, blah, blah:

„We’ve worked with CAPE to study how we meet the requirements for the B61 while ensuring that we’re being responsible stewards of taxpayer dollars. We’re currently doing the required engineering and design work on the B61 which will allow us to make key decisions that we can then use to inform a well researched and validated cost baseline.

All of the information we’ve gathered, including the CAPE study, will help us check any final conclusions against a long list of variables so that we’re certain we have a cost baseline

that is as accurate as possible.” **Josh McConaha, National Nuclear Security Administration** (4 Nov. 2012)

Siegbahn suggested that, if all *scientific* research of FOA immediately became public and subject to independent peer review, he would consider the offer.**

There were 61 kg (*critical mass of a slab of uranium 235, U235, metal*) or about  $4 \times 10^{26}$  or 400 000 000 000 000 000 000 000 uranium-235 (U235) atoms, we were told, in the very heavy 4 400 (!) kg Hiroshima atomic bomb 1945 (equivalent to 15 kilo ton of TNT), i.e. only 1.4% of the atomic bomb was material that could explode, but only 1.5% of the 1.4% or 600 000 000 000 000 000 000 U235 atoms actually fissioned or split releasing energy (equivalent to 15 kilo ton of TNT exploding), when the bomb allegedly exploded and released pure energy (and not gas of burnt TNT).

Read below of further details of the very, very heavy, US atomic bomb with only 61 kg U235 inside and how it allegedly exploded 6 August 1945 and killed mostly civilians and children and destroyed little of military value.

You only need 61 kg of Uranium 235 to destroy Hiroshima and it is easily accomplished. Will it work? Evidently not.

## ***Introduction – just **Propaganda** to scare you***



Many people today, 2014, apart from **being afraid of terrorists**, are also curious how a military, atomic bomb functions.

The death toll will be high, but there are opportunities to save tens to hundreds of thousands of lives.”  
But do not worry too much. It is just a joke.

### **The one million °C Heat and one thousand bar Pressure Blast Wave with its positive and negative Phases**

According the paper **Blast Loading and Blast Effects on Structures – An Overview**, by T. Ngo, P. Mendis, A. Gupta & J. Ramsay, The University of Melbourne, Australia, 2007 we learn:

„An explosion is defined as a large-scale, rapid and sudden release of **energy**. ... In a nuclear explosion, **energy** is released from the formation of different atomic nuclei by the redistribution of the protons and neutrons within the interacting nuclei (sic), whereas the rapid oxidation of fuel elements (carbon and hydrogen atomics) is the main source of **energy** in the case of **chemical explosions**. ...

The detonation of a condensed high explosive generates hot gases under pressure up to 300 kilo bar and a temperature of about 3 000-4 000C°. ... The hot gas expands forcing out the volume it occupies. As a consequence, a layer of compressed air (blast wave) forms in front of this gas volume containing most of the **energy** released by the explosion.

Blast wave instantaneously increases to a value of pressure

above the ambient atmospheric pressure. This is referred to as the **side-on overpressure** that decays as the shock wave expands outward from the explosion source. After a short time, the pressure behind the front may drop below the ambient pressure (Figure 1).

During such a negative phase, **a partial vacuum is created** and air is sucked in. This is also accompanied by high suction winds that carry the debris for long distances away from the explosion source”.

*A chemical explosive* is thus a compound or mixture which, upon the application of heat or shock, decomposes or rearranges with extreme rapidity, yielding much *gas* and heat. Chemical explosions normally take place at ground level and the gas forms a *mushroom cloud* rising in the sky after the explosion.

It is suggested by many *experts'* that a nuclear explosion, **if** it really can take place, generates **pure energy** and no hot gases of a chemical explosion producing black smoke but *something else – invisible energy corresponding to 20 000 ton of TNT exploding* – heating up 1 kg of new atomics and 60 kg of unsplit uranium atomics and 4 360 kg of scrap metal making up the bomb ... and the surrounding air. No *mushroom cloud* will be produced by such an explosion high in the air ... if it can take place.

**The *pure energy* of the exploding atomic bomb, we are told, heats up and increases the pressure of the surrounding atmosphere air so it expands producing a fireball with diameter 200 meters after 0.016 seconds and a blast wave displacing outwards in the cool outside air (seen on many fake US propaganda films) at a very high velocity and with an initial pressure of a thousand bar and an initial temperature of a million °C**

Such an expanding high pressure and temperature fireball and blast wave would evidently cause more damage than a simple



chemical bomb and its hot gases of rapid, local combustion of chemicals.

The atomic blast wave could not be directed – it would go off in all 360° directions – and destroy anything being hit. If the bomb goes off 600 meters up in the air, the pure energy escapes in all directions and the energy directed towards ground will damage the ground and be absorbed by the ground. Evidently the velocity, pressure and temperature of the blast wave

are reduced with time elapsed and distance travelled.

***Nuclear detonations produced high above the ground do not create mushroom clouds!***

**US official propaganda** has a slightly different description of the devastating blast wave:

„The ... (blast) wave travelled out in all directions from the explosion. The blast effects produced were uniform, and **essentially those of conventional large high-explosive** (chemical) weapons though on a much larger scale.

Thus, instead of localized effects such as the collapse of a roof truss or wall panel, **entire buildings were crushed** or distorted as units. The blast pressure, as with high explosives,

rose **almost instantaneously** (?sic?) to a peak, declined more slowly, and then fell below atmospheric pressure for a period about three times the period during which it was above atmospheric pressure. The positive period—that during which the pressure was greater than atmospheric—was of much greater peak pressure than the succeeding, or negative phase.

Short though the positive phase was—**probably only slightly longer than a second**—it lasted longer than the positive phase of ordinary bombs. Thus the effect of the atomic bomb on buildings was usually that of a powerful push, which shoved buildings over or left them leaning, whereas high

explosive (chemical) bombs strike sharply and much more briefly and tend to punch holes in walls.

**The duration was also long enough so that almost all building failures came during the positive phase.** Comparatively few evidences were found of failures of members during the longer but less intense negative phase; window shutters blown outwards toward the explosion were very rare.”

So the peak, side-on overpressure of an atomic bomb blast may be 1 thousand bar and the blast wave travels ~100 meter in 0.016 seconds or **6 250 m/s** at the beginning according photographic evidence (see below).

The blast wave hits ground after about 0.1 second, if the bomb explodes at 600 m altitude. An area with radius 3 000 meters, like central Hiroshima, was then destroyed, blown away outwards, in less than ten seconds assuming an **average blast wave velocity of 300 m/s** during that time.

The positive phase was 1 second, the blast wave was then say 1 000 meters away, **assuming average blast wave velocity 1 000 m/s** during that time, when reduced pressure below 1 bar developed, the negative phase started, and cool air was sucked into the vacuum for say 3 seconds. That anything should remain standing and catch fire within 1 000 meters during the 4 seconds, maybe longer, passage of the blast wave and its positive and negative phase appears unlikely.

The temperature of the heat wave associated with the blast wave probably also fell from 1 million °C to 6 000°C after a second or 1 000°C after 10 seconds but still high enough to vaporize objects being in the way. The amount of energy released in the combined blast and heat wave was evidently enormous. Any office building in the vicinity would evidently ... disappear! Wiped away.

### ***A US B-29 plane dropping napalm bombs on civilians***

We are **told** that the Hiroshima atomic bomb was released at 0815 hours local time, from an altitude of 9 855 meters by some US terrorists in a plane named **Enola Gay**.

A Plane dropped the atomic Bomb 6 August 1945 – No Parachute Retarder.

The plane was type **B-29** (right) that normally dropped 450 napalm fire bombs each of 10 kg (total 4 500 kg) on people, children, houses, schools and hospitals and similarly non-military targets on ground below.

About 45 fire bombs could be dropped simultaneously at 10 seconds intervals in a so called carpet bombing attack at low altitude, so 450 bombs could be dropped during one and a half minute. Imagine 400 B-29s dropping 180 000 napalm bombs in a joint attack. With luck only solid houses not being directly hit would remain standing.

Houses with rather solid roofs would not be affected – the bombs would bounce off. It had happened in Japan several times before and the result was several square kilometers of destroyed, burnt down *housing* areas in Japanese towns and only solid building standing.

Evidently this type of military attack was not suitable against small, industrial targets or even military troops. It was designed only to kill civilians of all ages. It was pure terrorism as terrorists targets innocent civilians.

Now *one* B-29 plane was converted to carry and drop only *one* atomic bomb – **alone – or Enola** – of **4 400 kg** with **61 critical mass kilograms** uranium 235 inside.

Imagine releasing *one* such heavy bomb in *one* go from a little plane. It had never been done before. How it was done is

described at around 36.50 in this **propaganda video**. Admire the cheap actors playing the bomb plane crew that never existed ... like the bomb.

We are told that ...

... **57 seconds later** (no parachute retarder used), at the predetermined altitude of 600 meters, the **4 400 kg** bomb detonated directly over Shima Surgical Clinic (and close to the Bank of Japan building) in an instant killing 75 000 civilians; the original aiming point was the Aioi Bridge, but wind blew it a little off course, we are made to believe.

The lonely bomb thus dropped 9 255 meters in **57 seconds**. Average *vertical* velocity of the bomb was thus 162.4 m/s. If start *vertical* velocity was 0 and final velocity was 324.7 m/s (almost the speed of sound), it accelerated vertically at rate 5.7 m/s or 0.58g. Air resistance apparently slowed down the bomb.

Start *horizontal* velocity was same as the plane's speed, say 100 m/s, but was reduced due to air friction, while the plane continued forward.

Say that bomb **horizontal** speed was reduced to 50 m/s after 57 seconds, then the average *horizontal* speed was 75 m/s and the bomb horizontal displacement during fall until explosion was 4 275 meters , i.e. the distance away from the target when dropping the bomb. The plane continued 5 700 meters at constant altitude.

Had the lonely bomb dropped another two seconds, it would have crashed against the ground ... and been destroyed ... and would never explode. That it actually managed to explode at 600 m altitude, while travelling at 324.7 m/s *vertical* speed and *horizontal* speed say 50 m/s after **57 seconds** fly time, is evidently just propaganda.

How to trigger a detonation at 328.5 m/s total speed at exactly the right time using 1945 technology is not clear, as it had never been done before or after. Try to Google for the answer.

You'll find nothing. But 100's of websites suggest that it was just done.

Note that the Hiroshima bomb 1945 had fixed tail fins like the 200 **B61 Silver Bullet** atomic gravity bombs.

If the plane made 360 km/h or 100 m/s speed, when dropping the bomb and continued straight on, the plane would be only 9-10 km above from the explosion, i.e. 16 times further away than the Bank of Japan building below the explosion. Imagine if the bomb had exploded a little earlier. The plane would have been wiped away.

Anyway, an area of no military value with radius ~2 000 meters was wiped out by the Hiroshima lonely bomb, we are told. It is suggested a 200 meters diameter fireball was created in 0.016 seconds driving the blast wave in all directions. The blast wave then hit ground and destroyed Hiroshima and killed 75 000 persons within a second ... we are supposed to believe.

But it is just propaganda. Probably only 7 000 persons died in the napalm bombing raid lasting some hours, so most people could escape to surrounding mountains. They were just part of the US/Japan show!

The atomic blast wave originating from release of *pure energy* heating up 61 kg of split and unsplit uranium atoms corresponding to 20 000 kg of TNT exploding apparently displaced in all 360° directions at great velocity, pressure and temperature until hitting something, e.g. the ground straight below, incl. the Japan Bank buildings with their flat roofs, pushing down, or anything at the side, pushing it sideways (or the plane above pushing it upwards).

The atomic blast wave should then bounce off whatever being hit unless what was hit was vaporized. It is like a wave at sea in the interface water/air hitting a shore (or a ship). The wave bounces (or the ship bounces). Compare also a tsunami wave hitting solid land. In that case the tsunami wave first pulls away the water close to shore – the water disappears but is actually sucked away – and then a wall of water arrives – the tsunami – destroying anything in its way.

Evidently >80-90% of the energy released 600 meters above ground just went straight up into the air and did no damage at all. Not even the plane dropping the bomb was affected. A second WMD bomb was allegedly dropped late morning on a suburb of Nagasaki a few days later killing more innocent children.

There are many strange eye witness testimonies of the Hiroshima and Nagasaki atomic bombings all suggesting a bright FLASH accompanied by a rush of heat followed by a huge pressure wave and the rumbling sound of an explosion lasting a second. Some unlucky people were then vaporized!

If you are being vaporized, you cannot give testimony, of course. There are many photos of persons having being vaporized. They are just dark patches on a brighter background and how the photographer knows that it was a vaporized

person is hard to understand.

Many people including children worry today 2013 a lot about that an atomic bomb will be used again and kill or vaporize innocent people in an awful terror attack. **A third ,fantasy' bomb** was also in the making 1945! Of course. Like this:

## *Enriched Uranium Production ...*

*„Enriched uranium production (in USA 1945) is more difficult to summarize since there were three different enrichment processes in use that had interconnected production. The Y-12 plant calutrons also had reached maximum output early in 1945, but the amount of weapon-grade uranium this translates into varies depending on the enrichment of the feedstock.*

*Initially this was natural uranium giving a production of weapon-grade uranium of some 6 kg/month. (Imagine that – one year just to producing the uranium for another Hiroshima bomb)*

*But soon the S-50 thermal diffusion plant began feeding 0.89% enriched uranium, followed by 1.1% enriched feed from the K-25 gaseous diffusion plant. The established production process was then: thermal diffusion (to 0.89%) -> gaseous diffusion (to 1.1%) -> alpha calutron (to 20%) -> beta calutron (up to 89%).*

*Of these three plants, the K-25 plant had by far the greatest separation capacity and as it progressively came on line throughout 1945 the importance of the other plants decreased.*

*When enough stages had been added to K-25 to allow 20% enrichment, the alpha calutrons were slated to be shut down even if the war continued.*

## *Napalm Carpet Bombing Beyond Imagination*



„In the (spring and) summer of 1945, the U.S. Army Air Force carried out one of the most intense campaigns of city destruction in the history of the world. Sixty-eight (sic) cities in Japan were attacked and all of them were either partially or completely destroyed.



An estimated 1.7 million people were made homeless, 300,000 were killed, and 750,000 were wounded. ... The destruction caused by conventional (terrorist napalm carpet bombing) attacks was huge. Night after night, all summer long, (Japanese) cities would go up in smoke.”**Source**

As media did not report this *the most intense campaigns of city destruction in the history of the world*, nobody gave a damn. Hiroshima and Nagasaki were simply destroyed by similar US conventional napalm, carpet, morning 3 to 5 a.m., terror bombing raids by 300 – 400 B-29 planes taking off from Iwo Jima and other islands piloted by very young and stupid American boys dropping 1 500 tons of **Rocky Mountains Arsenal** made napalm bombs like **Tokyo**, Yokohama (29 May 1945\*), Nagoya and 90+ other Japanese cities in 1945 killing 100 000’s of innocent civilians. „Although Tokyo would eventually be bombed on over one hundred separate occasions, one attack in particular resulted in



unprecedented human suffering: the air raid that took place in the early hours of **March 10, 1945**.

On this night, the B-29s made the heavily populated Shitamachi district of downtown Tokyo their target. Because the purpose of this raid was to demoralize the civilian population, it had several characteristics that set it apart from previous air raids.

This was the first nighttime raid on a Japanese city, which allowed an unprecedented number of B-29s – around three hundred – to better avoid ground-to-air fire even though they flew at a relatively low altitude in order to carry out an indiscriminate carpet bombing raid. Also, one must consider the deadly nature of the bombs themselves.

Somewhere in the neighborhood of **1 700 tons of deadly napalm** incendiaries were poured into the city. The attack itself lasted less than two hours, but because the Shitamachi area was so densely covered in wooden buildings and because the flames were fanned by a seasonal north wind, everything was consumed in a raging wave of fire. In a single night, the history and fate of Tokyo were altered forever.

An estimated **1,000,000 people were left homeless**, countless numbers of civilians were injured, and **100 000 precious lives were lost.**”

The Roosevelt Hiroshima atomic bomb never existed because it didn't work.

That it worked was just **propaganda** spread by various insiders to other insiders before and after the show. Like the Nagasaki bomb.

Both Japanese towns were simply destroyed by a US, standard, napalm, carpet terror bombing by 300-400 B-29 planes raid early morning followed by single petrol bombs exploding and setting fire to a cloud of petrol mist above the towns looking like a flash ... that could be reported as an **atomic bomb**.

The Japanese houses were generally simple wooden structures that burnt down quickly. Growing trees on the other hand didn't burn so easy. And walls of concrete and brick buildings remained intact. Solid bank buildings were not even damaged inside!

The napalm bombs were made by the US **Rocky Mountains Arsenal** area of which that today is an ecological disaster that will cost US\$ billions to clean up.

US propaganda June 8, 2013, suggests, e.g.:

„Japanese intelligence was predicting that U.S. forces might not invade for months. Soviet forces, on the other hand, could be in Japan proper in as little as 10 days. The Soviet invasion made a decision on ending the war extremely time sensitive.**Source**

Evidently Soviet forces had few ships in the Far east to invade Japan 1945. So Japan capitulated mid August 1945 and *only* USA occupied Japan until 1952. USSR and others just looked on. USA immediately created the Civil Censorship Detachment (CCD) within its Civil Information Section. CCD was secret. You could not even say that censorship existed.

Anybody in Japan taking photos of Hiroshima and Nagasaki and suggesting, e.g. that the two atomic bombs were fake was simply arrested and maybe executed because such suggestions disturbed public tranquility. How was it possible?

The CCD was run by United Stasi of America's general **Charles A. Willoughby** in pure Soviet style. **Charles** apparently was a psychopath clever to invent things and as such suitable for US (Nazi Germany, USSR ...) Army intelligence and counter-intelligence services. The propaganda lies and methods enforced by **Charles A. Willoughby** in Japan 1945-1952 are still on, of course ... 2013.

**KILLING OUR OWN – The Disaster of America’s Experience with atomic Radiation** by Harvey Wasserman & Norman Solomon with Robert Alvarez & Eleanor Walters issued as a Delta Book 1982 is typical. We are told that in the 1950’s young farm boys in small villages in remote areas of the USA saw atomic bombs explode in the distance and were later contaminated and died.

Richard Rhodes has, e.g., given the definitive story of man’s most awesome discovery and invention. Told in rich human, political, and scientific detail, **The Making of the atomic Bomb** is a narrative tour de force and a document with literary power commensurate with its subject:

Few great discoveries have evolved so swiftly-or have been so misunderstood. From the theoretical discussions of nuclear energy to the bright glare of Trinity, there was a span of hardly more than twenty-five years. What began as merely an interesting speculative problem in physics grew into the Manhattan Project, and then into the bomb, with frightening rapidity, while scientists known only to their peers – Szilard, Teller, Oppenheimer, Bohr, Meitner, Fermi, Lawrence, and von Neumann-stepped from their ivory towers into the limelight.

But Wasserman, Solomon and Rhodes are just copying and pasting stupid propaganda. An atomic WMD did not work 1945 or 1953 and doesn’t work today. Isn’t it good news? The US propaganda worked very well 1945 as the Japanese military government at the time was part of the deal.

The Japanese happily played along and announced that two atomic bombs had hit Japan ... and that Japan must surrender. And the USSR would not occupy Japan. Everybody was very happy.

Of course millions of Japanese were almost starved to death during the US military occupation 1945-1952 of Japan in order not to make trouble. American secret censorship made the rest. Historians were fooled. It works 2013.

Except **Klaus Fuchs, Julius and Ethel Rosenberg** and some others.

**Julius and Ethel Rosenberg** were convicted of conspiracy to commit espionage during a time of war and to the passing of information about the atomic bomb (that it didn't work!) to the Soviet Union and allegedly executed 1953, actually murdered.

**Klaus Fuchs** - above - was a German physicist that escaped from Nazi Germany and studied in Great Britain in the 1930's. He was 1942 persuaded to work as a civilian for the US



Manhattan project to develop the atomic bomb in UK, Canada and at Los Alamos, NM, USA and to sign the declaration form of the Official Secrets Act that provides for the protection of state secrets and official information, mainly related to national security.

Poor Fuchs could therefore not tell anybody what he was doing. Fuchs apparently soon found out that the Manhattan project was a failure ... but he could not tell anybody. National security! Crazy, wasn't it. So Klaus told the stupid secret about the atomic bomb that didn't work to some representatives of the USSR, so that they knew what was going on.

He shouldn't have done that. 1950 Fuchs was arrested and jailed, later condemned to 14 years prison for treason after a 90 minutes trial in the UK. Tough luck. 9 years later he was kicked out of UK and settled at Dresden, not far from my house at **Freiberg**.

The Fuchs' arrest and trial and the Rosenbergs' executions were clear signs to any civilian physicist in the know that atomic bombs do not work – shut up or ...

## *The Soviet Atomic Bomb*

4 to 11 February 1945 Roosevelt, Churchill and Stalin met at Yalta, USSR, to discuss how to divide the world after the defeats of Nazi-Germany and Japan. Roosevelt/Churchill indicated that they had **a little surprise** for Stalin. And the night 16/17 February central Dresden (Altstadt and Neustadt), Germany, a town of no military or industrial value was completely destroyed or burnt down by US/UK carpet napalm terror bombing raids.

The only purpose was to show Stalin what happens to countries that do not respect agreements made. The Red Army arrived at Dresden early May 1945 and could see the result of UK and US governments terrorism. There were more military industry at little Freiberg 35 kms west than at 15 times bigger

Dresden but Freiberg was never bombed. **My house there** is still standing.

The US (fake) first atomic test bomb exploded in New Mexico 16 July 1945 and president Truman was informed who indicated to USSR dictator Stalin 24 July at Potsdam, Germany, that **USA had a new weapon**. Klaus Fuchs had already 1 July 1945 told his USSR spy masters about the US test of the (fake) bomb so Stalin was in the picture.

More (fake) US atomic bombs destroyed Hiroshima and Nagasaki in Japan 6 and 9 August. In reality it was the same 400 B29s piloted by young, stupid American boys 18-19 years old not having a clue where they were that had destroyed Dresden a night in February that now destroyed Hiroshima and Nagasaki during nights in August 1945. The atomic bomb flash, blah, blah, early morning was just propaganda.

Back in Moscow Stalin created 20 August 1945 a secret committee to produce a Soviet *,atomic'* bomb, fake of course, as quickly as possible.

The committee consisted of three communist gangsters, Malenkov, Voznessenski and Zaveniaguine and three corrupt scientists, Kurtchatov, Joffé and Kapitsa. Kapitsa had already 11 October 1941 written an article in *Pravda* about how to build an atomic bomb that could wipe out a city, so it was no news.

The committee also got, 11 October, a full set of plans of the US (fake) bomb provided by Fuchs so it was just to copy and paste and ... voilà – the USSR would have its (fake) bomb at little cost. However, USSR had no (fake) uranium ore or metal to produce the (fake) bomb. To produce a fake atomic bomb you need fake uranium metal to make the hoax more realistic. And the uranium could anyway be used in peaceful, soviet, nuclear power plants.



## *Wismut AG*

A quick study revealed that Saxony/Erzgebirge in the by the USSR occupied part of Germany had plenty of old, abandoned silver mines full of uranium oxide (pechblende). USSR secret service (NKVD/KGB) thus created (1945 or 1947) a German limited company, **Wismut AG**, to pursue mining uranium in Saxony.

One problem was that 95%+ of all Saxon mines, not very deep, say average 50 meters, but long, had been closed around 1900 being emptied of all silver and that the mining equipment was medieval or 1800-style – hammer, chisel and brute human force. Germany had never mined uranium before.

Uranium ore mining therefore started 1945 with hammer and chisel and **Wismut AG** managed to produce just 10 000 kg (or ten tons!) of very low, ~0.02%, grade uranium oxide content ore **1946** that was shipped off by train to Semipalatinsk in wooden boxes to become uranium metal, which is fairly simple.

The uranium metal shall then be divided into fissionable and non-fissionable uranium and that is very complicated. The USSR (fake) bomb was being built in great secrecy by 300 000 Gulag prisoners in the vicinity. Simple calculations show that less than 2 kg **uranium-238/235** was in that Saxon ore 1946 ... but you need much, much more to build a bomb.

As explained below to, e.g., obtain 61 kg of pure **uranium-235 (U-235)** metal to make an atomic bomb, you need about 8 400 kg or 8.4 ton of uranium metal to separate the **uranium-235 (U-235)** from. And to get 8.4 ton of uranium metal you need >40 000 tons of Saxon uranium ore.

But ... hast Du mir gesehen ... very low grade uranium ore production increased in Saxony and surroundings thanks to a friend of mine working for the corrupt **Wismut AG** at Objekt 15 and otherwise and on **26 August 1949** the USSR announced that it had exploded its (fake) atomic bomb at 08.00 hrs local

time. In all secrecy, of course. Western media published the lies as truth. The cold war had started.

## *300 Stalin Prizes*

On 29 September 1949 about 300 USSR engineers and scientists received the Stalin Prize of 1st or 2nd order for the achievement to put a Soviet (fake) atomic bomb together. Imagine that, the USSR managed to build in all secrecy (or copy paste together using Fuchs' fake plans) a (fake) atomic bomb from scratch in only four years. USA thought it would take the USSR 20 years. All fake of course.

**There is no business like the fake nuke business. It goes full speed 2014! Iran and North Korea are in the lead!** Stalin was then the most powerful man in the world, he thought or dreamt. But he was just a terrorist having killed millions of civilians in USSR since 1928. Stalin was also sick, alcoholic, old and useless with no friends and didn't know what to do with his fake bomb.

To scare him 1st November 1952 United States exploded its first hydrogen bomb triggered by a small (fake) atomic bomb. It was 100 times stronger than the atomic bomb but of course 100% fake. Stalin didn't like it and died around 1 March 1953 murdered, shot, poisoned, sick or just faded away. Nobody knows how he died. Another mystery. But 1st August 1953 the USSR then tested its first hydrogen bomb, too, triggered by a small atomic bomb.

It was 10 times stronger than the US bomb! It was of course also fake but western media said it was true. The cold war was heating up. USSR never used its atomic bomb toys and USSR ceased to exist 1991.

The USSR/Stalin atomic bombs were just fake for 42 years. But the world believed that the USSR had the atomic bombs ready to drop them anywhere. Modern Russia is keeping up the illusion. Doesn't cost them much ... but why not state today it

was a hoax? Aha, Russia is still an atomic bomb power!

## *Atomic Bomb Radiation*

Over the decades the American and Japanese governments have spent more than \$100 million to **try to understand just what the radiation from the atomic bombs did** to the people of Hiroshima and Nagasaki. One interpretation is that no atomic bombs were dropped at all. Evidently during seven years of US occupation of Japan no radiation studies of Hiroshima and Nagasaki were done ... or faked. Censorship cannot do everything.

## *The French Atomic Bomb*

But didn't France governed by our famous Général explode atomic bombs 1960 and 1966, you may ask? Oui, the Général produced his first A-show February 13, 1960, in the middle of desert Sahara and 60 persons flown in witnessed it. Of course, they were all asked to close their eyes, when the bomb exploded (to protect their eyes) ... and were later shown photos/films of what they were supposed to have seen.

Imagine all nonsense about the **LGM-118 Peacekeeper**:

The LGM-118A Peacekeeper, also known as the MX missile (for Missile-eXperimental), was a land-based ICBM deployed by the United States starting in 1986. The Peacekeeper was a MIRV missile; it could carry up to 10 re-entry vehicles, each armed with a 300-kiloton W87 warhead/MK-21 RVs. A total of 50 missiles were deployed after a long and troubled development period.

As nuclear weapons do not work, imagine all money wasted (actually stolen by US Pentagon insiders) with the LGM-118 Peacekeeper.

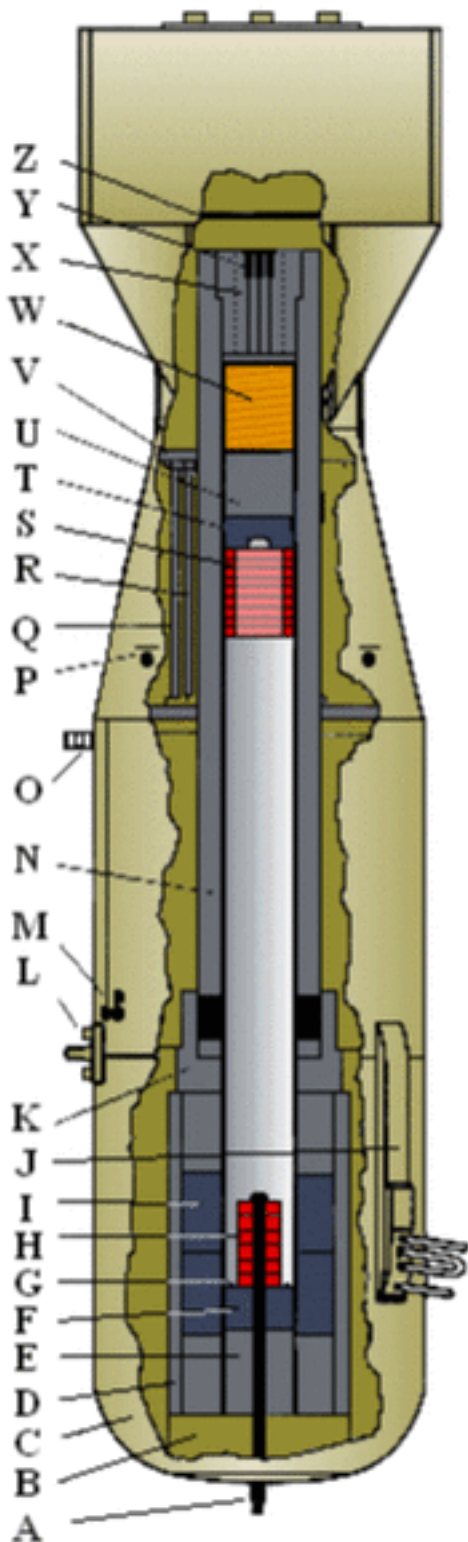

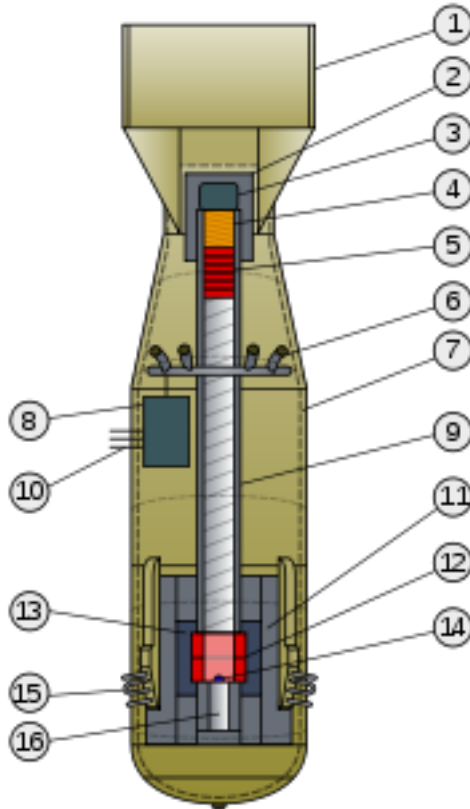

**Anyone, incl. Iran, can build a 4 400 kg heavy atomic Bomb ... but it does not work**

So the US atomic bomb is not very complex or big – about 3 meters long with diameter 0.7 meter and mass 4 400 kg!! Anyone can build it! But it doesn't work. Full details of the physics behind the 4 400 kg is available in the top secret **Los Alamos Primer**.

Item **A** is a front nose lock nut (!! ) attached to a 1" (~2.54 cm) diameter main steel rod holding the 6 **uranium-235 metal (U-235) target rings** (item **H**) in place on top of a Tungsten-Carbide tamper plug (item **F**) and inside the 6.5"

(16.5 cm) inside diameter Tungsten-Carbide tamper cylinder sleeve (item I).

Each U-235 **target ring** weighs ~5.08 kg, i.e. all 6 **target rings** weigh together ~30.5 kg.

A **target ring** has inside diameter ~2.54 cm (1") and outside diameter ~11.8 cm (4.65") and height ~2.57 cm (1.01") and volume 268 cm<sup>3</sup> and weighs ~5.08 kg, because the density of the metal U-235 is about 18.95 g/cm<sup>3</sup>.

Total height of the 6 **target rings** is 15.4 cm (6.06").

If the front nose locknut (item A) is not secured, the **target rings** (item H) will drop off! And items B, C, F, G and I will be loose.

Item S is the 9 uranium-235 metal (U-235) **projectile rings**.

Each **projectile ring** weighs ~3.39 kg and has height 1.71 cm (0.67").

The inside diameter is ~11.8 cm (4.65") and the outside diameter is ~16.5 cm (6.5") so the **projectile rings** can slide inside the cylinder sleeve – item I and the 6.5" bore gun tube – item N. Total height of item S is 15.4 cm, i.e. same as item H. How the **projectile rings** (item S) and items T, U and W are secured inside the cylinder sleeve/gun tube and do not drop down by themselves is not clear! Nine **projectile rings** weigh ~30.5 kg.

The **target rings** and **projectile rings** have combined (*critical*) mass 61 kg and volume 3 219 cm<sup>3</sup> (a cube of uranium-235 with side 14.77 cm) that will ,explode' when pushed together. The remaining mass of the bomb – 4 339 kg – is all the other lettered items seen above.

US Army designed it VERY HEAVY 1945! Why you need 4 339 kg of scrap to push 2 times 30.5 kg of uranium-235 together is still a military secret. National security, you know! Remember Klaus Fuchs!

Another **fake drawing** of the **VERY HEAVY** 'Little Boy' is shown right. The basic principle is the same but the details differ completely. This is normal when idiotic military hardware is used as propaganda. There is no Item A a front nose lock nut, etc.

It would evidently be much simpler to just have a 60 kg cube about 14.8\*14.8\*14.8 cm of uranium-235 with a hole where you can inject a piece of 1 kg of uranium-235 at a speed of >1 000 m/s using a little mechanical device, so it explodes, when *critical mass* 61 kg is suddenly reached.

This mechanical device incl. 61 kg uranium-235 weighs say 70 kg. Put it in a bag with weight 10 kg and you have a Björkman atomic bomb (left) that only weighs 80 kg. Imagine that a little cube of uranium-235 can explode in a little bag! Of course one 1 kg piece must be injected at a speed of >1 000 m/s into the other 60 kg piece.

Easier to handle than the stupid 4 400 kg monster allegedly used at Hiroshima.

**But you need Uranium-235 ... and it is a little complicated**

**Uranium-235 (U235)** is a *metal* and doesn't cost very much and is not rare. About 53 000 tons of **uranium** are produced annually 2012.

A friend of mine at **Freiberg, Saxony** (East Germany/DDR until 1990) worked for **Wismut AG**, 1948-1958, that produced 10 000 tons of uranium for USSR. Those were the times. **Wismut AG** was a private company (in communist DDR) 100% owned by the **KGB** (USSR secret intelligence/security agency) headed at the time by comrade Serov.

The USSR used the DDR uranium in their nuclear power plants. **KGB knew the US atomic bomb was a fake as KGB had spies everywhere in the USA fooling FBI for years.** So USSR produced their own communist atomic bomb! It didn't

cost them a kopek. It was just proletarian propaganda. It was never built. Only propaganda films and photos of fake Soviet atomic bombs were produced to impress the proletariat and put fear into the Americans.

One American, Paul Nitze, was behind the three most important reports that promoted the perception of a Soviet threat against the United States after World War II.

The first of these reports, NSC68, was instrumental in changing the policy of the Truman Administration, which initially did not perceive the Soviets as a major threat. The second Nitze report was the Gaither Report that, in 1957, said **the U.S. had fallen behind (!) the USSR in nuclear weaponry**. Didn't Nitze know that the USSR bomb was a propaganda hoax?



**Disc of U-235 made in USA! Just drill a hole and ... voilà ... a ring! Then compress it, or just drop it on the floor!? ... and BOOM!**

However **uranium-235 (U-235)** makes up only 0.72% of normal uranium metal and has to be separated from the remainder (mostly **uranium-238**) in special factories which makes **uranium-235 (U-235)** a little more expensive.

An **uranium-235 (U-235)** atomic has three neutrons less than an **uranium-238** atomic. To, e.g., obtain 61 kg of pure **uranium-235 (U-235)** metal you need about 8 400 kg or 8.4 ton of uranium to separate the **uranium-235 (U-235)** from. How to separate **uranium-235 (U-235)** from **uranium-238**?

Well, one way is, Iranian style since many years, that you treat the **uranium** with **fluorine, F**, so it becomes a gas – **UF<sub>6</sub>** – and then, in gas separators you separate the lighter **U-235 F<sub>6</sub>** molecules from the little (three neutrons) heavier **U-238 F<sub>6</sub>** molecules! And then you remove the fluorine again and have pure, metal **uranium-235 (U-235)**. Voilà!



Then you cast and machine the **target rings** and **projectile rings** of **uranium-235 (U-235)** in any workshop. **Uranium-235 (U-235)** is a metal like iron that can be shaped into **target rings** and **projectile rings**. Imagine drilling a dia 1" hole in a **target ring**. Aren't you worried it will **EXPLODE**?

It is, however 2012 – 67 years later, still **TOP SECRET**, what US factory managed to separate **U-235** from 10 tons of **U-238** by gas separation or whatever – magnetism? – and then making it, the **U-235**, a **72 kg metal slab** again and what workshop manufactured and drilled the **U-235** metal **target rings** and **projectile rings** in 1945!

Reason apparently being that no such workshop or technology existed at that time, 1942-1945, and no **rings** were ever manufactured. Of course, there was **Oak Ridge, TN**, with 75 000 people but they didn't know what they were doing.

Some people say **Clinton Engineer Works**, 20 miles west of Knoxville, TN, produced the **rings** using the **calutron electromagnetic isotope separation (EMIS) process**. Hundreds of thousands of magnetic type separators (!) driven by great amount of electricity were used by **Clinton Engineer Works** to produce some hundred kilograms of **U-235**.

Reason for so many separators was the relatively low product collection rate of the process and the long cycle time required to recover material between runs. The **rings** and the separators would otherwise be nice atomic museum show pieces! But ... it was all stupid **PROPAGANDA!**  
No **U-235** was ever produced and no separators existed!

Talking about **atomic museums** – there is **one** at Albuquerque, NM! It produces a lot of **propaganda about US nuclear bombs** and the **nonsense done nearby 1945**.

The first atomic bomb explosion at 5.30 am, July 16, 1945, 0.016 seconds after detonation at about 20 meters above ground. The *fireball* (?) is about 600 feet (200 m) wide.

The black specks silhouetted along the horizon are trees. The picture, allegedly taken by a high speed, 64 fps (one frame every 0.0156 seconds), B/W film camera at a distance 10 000 yard away, is a simple fake! Like this [video!](#)

Inside the fake *fireball* is *pure energy* that have heated up split and unsplit uranium atomics and the air to  $>1\ 000\ 000^{\circ}\text{C}$ . The pressure inside the *fireball* is originally  $>1\ 000\ 000$  bar, when it expands at great velocity in all directions ... if you believe the nonsens.

In this 1955 [film](#) you see a little (fake) atomic bomb go off, so next day place is safe to visit and have a look at the damages! All nuke bomb films are fake! Russian, American, French, etc.

According underpaid US scientists 1945 the atomic bomb above exploded (!), when the 9 [projectile rings](#) (item **S**) of 30.5 kg uranium-235 (U-235) were *mechanically* pushed over and *mechanically* compressed into (?) the 6 [target](#)

**rings** (item **H**) also of 30.5 kg **uranium-235 (U-235)** by the projectile Tungsten-Carbide disk (item **T**) at a speed of >1 000 m/s (according #20 of the **Los Alamos Primer**) and the projectile steel back (item **U**) in turn accelerated by exploding cordite power bags (item **W**). 4 Polonium-Beryllium initiators (item **G**) on the plug crushed by the **projectile rings** apparently started the magic atomic action (LOL!)?

This took place 600 meters above ground, when the bomb itself was dropping at 324.7 m/s speed.

Why the 9 **projectile rings** did not drop by themselves by gravity is not clear. Maybe they were glued together and to the disk glued to the steel back?

So an atomic bomb is very simple! Slide or drop or push (assisted by exploding cordite!)

9 **uranium-235 (U-235) projectile rings** over 6 **uranium-235 (U-235) target rings** and compress them together inside a Tungsten-Carbide tube (sleeve/disk/plug) a speed of >1 000 m/s and **fission** and ... **BOOM**. Children died! And do not forget to tighten item A – the front nose locknut on the steel rod!

Above is evidently pure nonsense. Stupid, idiotic propaganda. It does not work! Metal in contact with metal, be it gold, silver, lead, iron, uranium of any kind incl. **uranium-235 (U-235)** of any **critical mass**, do not fission exponentially and explode (initiated by Polonium-Beryllium) even after being **mechanically** compressed together a speed of >1 000 m/s ... suddenly.

What is supposed to happen to initiate fission? The **projectile rings** and their steel back (items **T** and **U**) – say weight 50 kgs – accelerate down the 2 meters long tube in microseconds and collide with the impact absorbing anvil (item **E**) with a velocity of  $v$  – say  $v = 150$  m/s, which is pretty high (more will blow the tube apart). The total energy applied at collision impact is 562.5 kJ and half of it is absorbed by the impact absorbing anvil

(item **E**) trying to push the **projectile rings** and its steel back (item **U**) back up the tube.

You know – **objects also bounce, not just compress, at impacts**. The remaining energy – 281.25 kJ – is supposed to radially compress mechanically the **projectile rings** and the **target rings** (total 61 kg) and adjacent items (say also 61 kg) but 2.3 kJ/kg energy will not compress metal a lot in any direction. **Compare energy required to destroy WTC 1/2!**

You really wonder what idiot or nuclear physicist came up with this crazy idea that two pieces of cold metal (**uranium-235**) mechanically compressed together using cordite would start to fission. Would really the two cold metal pieces merge into one? What really happens at the contact surface between the **projectile rings** and the **target rings**? Do the rings become one solid mass? And why would it explode?

**Uranium-235 only explodes if it has a critical Mass**

The *,experts'* have an answer to that. **Critical mass!** The **critical mass** is the smallest amount of fissile material needed for a sustained nuclear chain reaction. For **uranium-235, U-235**, the critical mass is 61 kg! If 30.5 kg of metal **U-235 projectile rings** are brought in mechanical, compressive contact with 30.5 kg of metal **U-235 target rings** they add up to **61 kg = critical mass!** A 3.39 kg **projectile ring** in contact with a 5.08 kg **target ring** does not produce fission! Why?

Because  $3.39 + 5.08 = 8.47$  kg is not a **critical mass**! On the other hand a sphere or ball of **uranium-235** with diameter 17 cm has a **critical mass of only 52 kg**. **Or:**

A mass may be exactly critical without being a perfect homogeneous sphere. More closely refining the shape toward a perfect sphere will make the mass supercritical. Conversely changing the shape to a less perfect sphere will decrease its reactivity and make it subcritical.

So a **52 kg sphere** of **uranium-235** is a critical mass like **61 kg** of *rings* of **uranium-235**. atomic physics is just a big laugh. Military secret, of course.

In retrospect it would have been much easier to allow two 26 kg half-spheres of **uranium-235** to collide than to play around with **projectile and target rings**.

And what damages are caused by cordite gases when the **projectile rings** or half-spheres have been pushed down the gun tube? Doesn't the whole atomic bomb assembly blow apart? LOL! OK, OK, it was never built! **It was just a joke**. Military propaganda 1945 worth US\$ 2 billion! LOL! And nuclear physicists believe it 2013.

### **But only 0.1% of a Uranium-235 atomic becomes Energy in an atomic Bomb**

But I agree. One **U-235** uranium atom may fission as discovered by Otto Hahn in the 1930's. You do not have to mechanically compress uranium metal rings in a tube for it. In a peaceful atomic power plant there is no mechanic compression of uranium atomics to keep the plant going.

When one **U-235** nucleus fissions into two lighter nuclei fragments or products (i.e. other atoms), about 0.1 percent of the mass of the uranium nucleus appears as fission **energy** of 202.5 MeV ... we are told (by some **underpaid physicist?**):

A. Typically ~169 MeV appears as the kinetic **energy** of the

nuclei fragments (new atomics), which fly apart at about **3% of the speed of light**, due to Coulomb repulsion. B. An average of 2.5 (?\*) neutrons are emitted, each with a kinetic **energy** of **~2 MeV** (total of 4.8 MeV).

C. The fission reaction also releases ~7 MeV in prompt gamma ray photons (light).

D.  $169 + 4.8 + 7 = 180.8$ . Where does the remaining  $202.5 - 180.8 = 21.7$  MeV energy go? Or is there a simple addition error?

Regardless, this means that a nuclear fission of **one (!)** atom emits about 3.5% of its **energy** as gamma rays, less than 2.5% of its **energy** as fast neutrons (total ~ 6%), and the rest as **kinetic energy** of fission fragments (this appears almost immediately when the fragments impact surrounding matter, e.g. water (?\*) in an nuclear power station, as simple heat, where **the reaction is controlled** at a certain constant temperature).

(\*that half a neutron is produced in fission of one **U-235** atom is to say the least strange! The other two neutrons are supposed to immediately fission two other **U-235** atoms – chain reaction! – but the energy 2 MeV is much too small ... according same underpaid physicist! And evidently the fragments first impact surrounding **U-235** metal ... and not water or air, i.e. the **U-235** metal piece is heated up first. If there is U-238 uranium in the bomb and a free neutron collides with it, it may become radioactive plutonium 238, which is very dangerous, we are told, etc, etc. )

Note that no matter is transformed into pure energy à la Einstein here. Only one atom is split into two other atoms – fragments – and some neutrons and gamma rays and as they are moving they represent kinetic **energy**.





## *However*

In an atomic bomb as described above (due to exponential chain reaction), this heat may serve to **raise the temperature to 100 million K** (kelvin) and cause secondary emission of soft X-rays, which convert some of this energy to ionizing radiation.

This is utter nonsense. Less temperature will simply melt the uranium **uranium-235 (U-235) metal assembly** that will flow or evaporate away. Therefore:

However in **nuclear reactors**, the fission fragment kinetic **energy** remains as low-temperature heat, which itself causes little or no ionization.

It is the speed of the neutron, when it hits the nucleus that has a lot to do with how likely a fission is to occur. One might think, intuitively, that if the neutron is going really fast that it has a better chance of “shattering” the nucleus, but that’s not really how it works. Actually, for the fissile nuclei such U-235 the **SLOWER** the neutron is going, the more probable fission is.

So slowed-down neutrons to maximize fission are an absolute requirement. And then from fission comes more neutrons, which continue the reaction. Well, mostly right. Actually, the neutrons born from fission are going really fast. Really, really fast. And they have to slow down to have a good chance of causing fission. That’s where the moderator comes in.

The moderator in a nuclear reactor is the material whose job it is to slow down neutrons without absorbing them. This slowing-down is done by neutrons bouncing off the nuclei of the atomics in the moderating material.

For most reactors, moderation takes place in the water that also cools the reactor. For a high-temperature reactor like the liquid-fluoride reactor, graphite (carbon) is used as the moderator. This was not really known in the 1940’s when the atomic bomb was said to have been invented

It is thus the moderated free neutrons that keep the fission going in a peaceful nuclear power reactor by heating the water. The **2 MeV** kinetic energy of a free neutron becomes 0.01 MeV kinetic energy and the rest – 1.99 MeV – heats up the water. But in 1945 it was **only 1.5% of the Uranium-235 critical Mass exploded or fissioned in an atomic Bomb.**

we are told by the 1945 atomic bomb engineers and manufacturers. Fission was discovered 1939 and 1945 everything was known about it by clever scientists we are told ... but made top secret for military reasons. How convenient.

How many **U-235** nuclei are there in a 61 kg atomic bomb described above? The answer is that there are about  $4 \times 10^{26}$  **U-235** nuclei in a little, 16.5 cm diameter, 15.4 cm high, 61 kg (critical mass, LOL) **U-235** atomic bomb two parts core, i.e. quite a lot of U-235 nuclei in the metal **target rings** and **projectile rings**.

Only 1.5% of the  $4 \times 10^{26}$  U-235 nuclei, i.e.  $6 \times 10^{24}$  nuclei are, according to unproven research 1944/5, supposed to fission during a few nanoseconds to produce an atomic bomb explosion according some strange, unproven theory.

98.5% of the nuclei do not fission as the **free neutrons** miss them and fly away, we are supposed to believe. Imagine that! 98.5%. Why not 100%?

So the following is supposed to happen in a **U-235** exponential chain reaction atomic explosion after two pieces of cold metal **U-235** are compressed together:

1. One metal **U-235** nucleus of total  $4 \times 10^{26}$  nuclei fissions and is split into two *fragments* of some kind at high speed (close to speed of light) and two or three **free neutrons** (also at high speed) due to mechanical compression. It is supposed this happen in the interface between the **projectile rings** and the **target rings**.

2. The two or three **free neutrons** miss 120-150 metal **U-235** nuclei in the vicinity because the nuclei are very small compared to the atomic itself but still manage to collide with 2 or 3 **U-235** nuclei that fission in turn and split into more fragments and another 2 or 3 **U-235** nuclei that again misses 120-150 **U-235** nuclei in the vicinity but manage to collide with 2 or 3 **U-235** nuclei, and so on until only  $6 \times 10^{24}$  **U-235** nuclei (1.5% of total) have fissioned during a few nanoseconds chain reaction.

3. The temperature increases  $1\,000\,000^\circ\text{C}$  and produces a flash and the energy heats the surrounding air over several kilometers that then rises to form a mushroom cloud.

4. The pressure increases 1 000 000 bar due to pure, white or blue, invisible energy (kinetic energy of the fragments) being released forming a blast wave that destroys the surroundings (except the Bank of Japan building and similar strong buildings).

5. Above only happens if the total mass of the two cold metal pieces being mechanically compressed is **critical**.

Why a dirty mushroom cloud of any type or color or a ball of fire hanging around in the sky is supposed to develop ... except on fake footage to impress stupid onlookers ... is not really clear. Hot air ball of fire rising?

If there are **U-238** nuclei mixed with the **U-235** nuclei, the neutron may transform the former into plutonium + radiation, i.e. the **U-238** nuclei are not split into fragments but transformed into another substance.

That the fragments (heat) do not melt the  $4 \times 10^{26}$  nuclei metal core is that fission goes faster than melting, we are told, etc, etc, blah, blah.

However, when the first (and only?) nucleus of  $4 \times 10^{26}$  **U-235** nuclei in the above bomb fissions (it is split

by **free neutrons** from somewhere – the Polonium-Beryllium initiators?), it will only heat the surrounding as it is not cooled and the 2.5 **free neutrons** will just fly away and produce nothing with their 2 MeV energy each. They cannot possibly collide with and fission anything. **They must be moderated to produce further fission like in an atomic power plant.**

The  $4 \times 10^{26}$  minus 1 remaining nuclei in the little dia 16.5 cm, 15.4 cm tall chunk of U-235 metal **target/projectile rings** will therefore not fission further. **The bomb does not work!** It always fizzles! Unless the cordite blows the whole thing apart and some innocent bystander gets a **target ring** or **projectile ring** in the face?

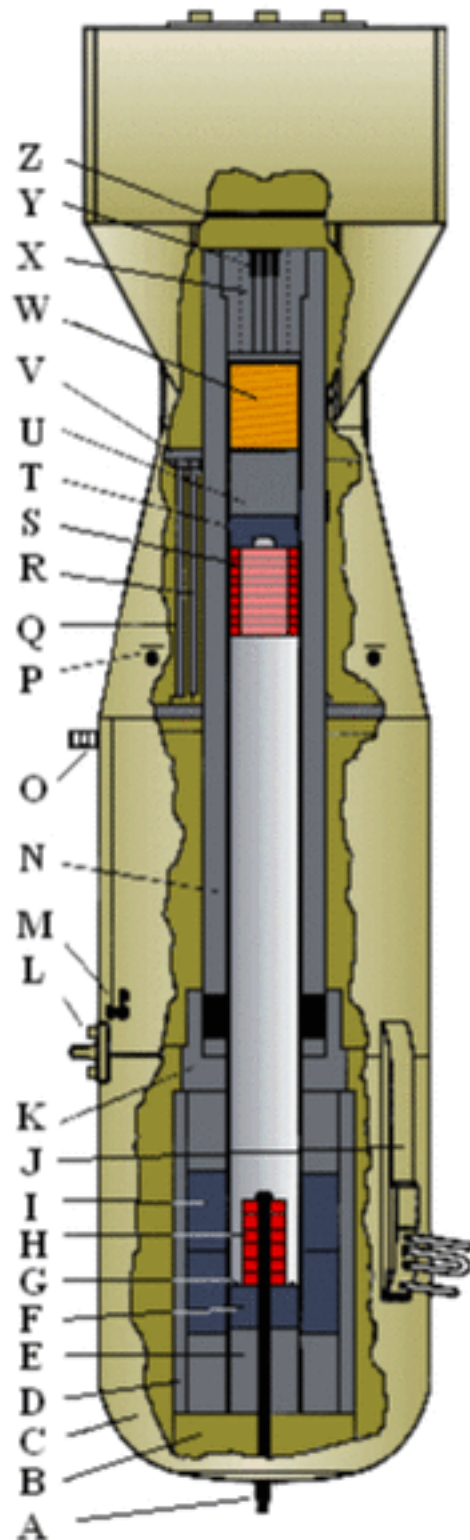

## *Fission Fizzle*

**Carey Sublette**, self-appointed nuclear expert (sic), has a very stupid explanation of fission fizzle:

**Oppenheimer**, the alleged master mind of the *fake* Hiroshima bomb, apparently thought it was all a joke.

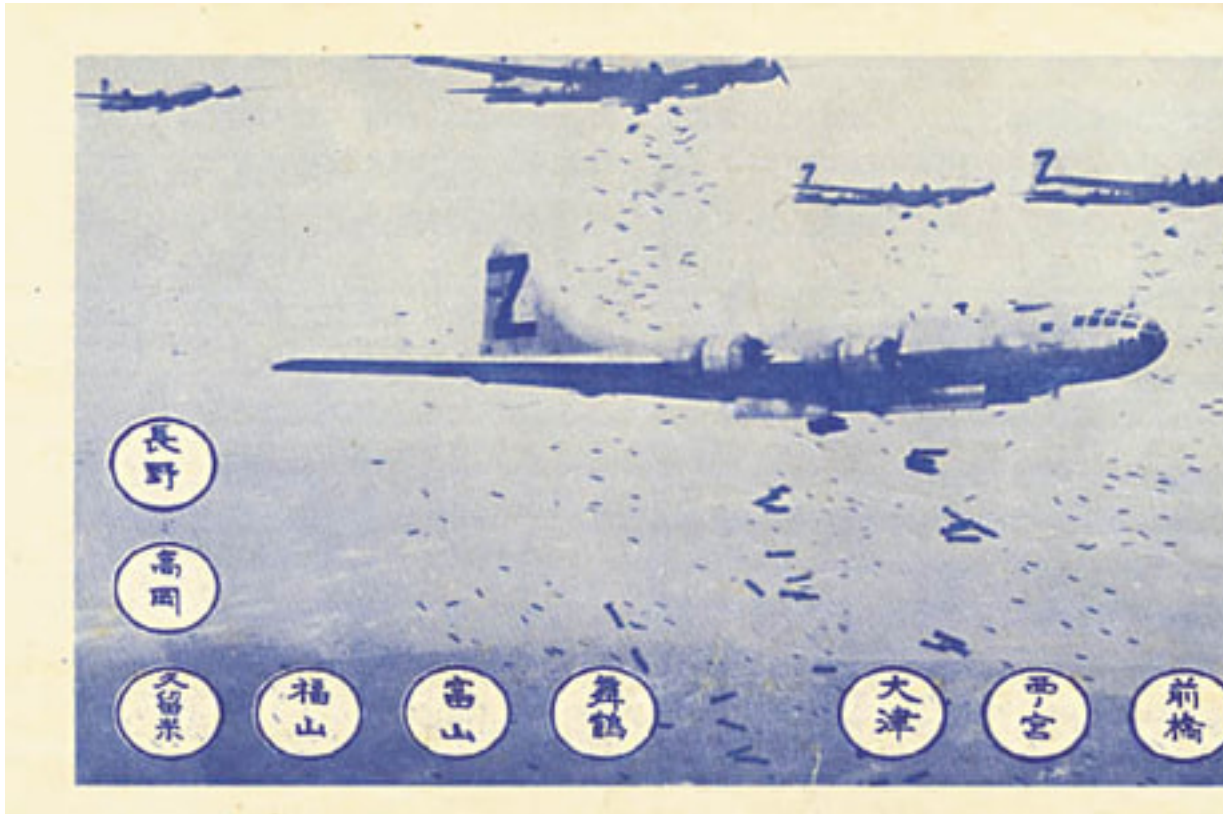
That nobody would get killed by the massive napalm carpet bombings of Hiroshima and Nagasaki. But **later propaganda** suggests otherwise:

Witt, Christina Walrond, David Albright, and Houston Wood:

„The authors use one significant quantity (SQ), defined as 25 kilograms of WGU (Weapon Grade Uranium), to represent the amount of WGU needed for a nuclear weapon. ... Currently, ISIS assesses that Iran would require at least 2-4 months to produce one SQ of WGU at the Natanz Fuel Enrichment Plant and would need to utilize its stocks of 3.5 and near 20 percent LEU.

The quickest estimates are 2 to 2.3 months, and they rely on an amount of near 20 percent LEU hexafluoride that was scheduled for conversion to another form as of August 2012. Growth in the stock of near 20 percent LEU reduces the time needed to break out, even though this stock is not currently large enough on its own to produce one SQ.”

As seen in chart right you need a fair amount of energy (and centrifuges) to enrich to 5% U235 for a nuclear power plant, i.e. 900 SWU, less energy (and centrifuges) to 20% U235 for medical use, i.e.  $1\ 125 - 900 = 225$  SWU, and much less to 95% U235 (and only a few centrifuges) for your *fake* atomic bomb, i.e.  $1\ 300 - 1\ 125 = 175$  SWU.

The reason is that the mass of material being enriched progressively diminishes and requires less effort relative to what has already been applied before.

- 3.11** *Psychological shock*
- 3.12** *Japan is a nice country ... and no atomic bombs exploded there*
- 3.13** *Atomic bomb testing ... by underpaid, summer working, American and British students*
- 3.14** *No scientific evidence that an atomic device can explode = good news!*
- 3.15** *Only risk is overheating and melting of the metal and surroundings*
- 3.16** *An exponential chain reaction is not possible .*
